Over the past 30 years, Ashoka has elected 3,000 leading social entrepreneurs as Ashoka Fellows, providing them with living stipends, professional support, and access to a global network of peers in 75 countries. In addition to supporting leading social entrepreneurs, Ashoka works with young people, institutions, companies, and individuals to multiply the number of changemakers.

For 30 years Ashoka has elected over 3000 Ashoka Fellows, providing them with living stipends, professional support and access to a global network in more than 70 countries.

Through a rigorous search and selection process, Ashoka are looking for those innovative visionaries who have founded organizations based on new ideas with potential to change societal problems at a systems level. Since 2009 Ashoka has elected 16 Ashoka Fellows in Scandinavia.



Heidi Wang: Noen, Ashoka Fellow Norway

Within the next ten years, the number of elderly people in Norway will double. With this older population comes a dramatic increase in the ailments that arise with aging, particularly dementia. Heidi is building a new resource in society for people with dementia that combines an emphasis on early diagnosis and prevention, focusing

on what remains rather than what they have lost. Heidi receives a three year living stipend, has connected to Ashoka's global network including pro-bono partners McKinsey for strategy, Geelmuyden-Kiese for PR and Boehringer Ingelheim. Heidi works closely with ASN in Norway, several serving on Noen's Board.



Thorkil Sonne: Specialisterne, Ashoka Fellow Denmark

People diagnosed with autism often end up alienated from the labor market and other societal platforms. Thorkil is turning the handicaps of autism into a competitive advantage in business, and opening up new opportunities for autistic adults. He has created a consultancy company, Specialisterne, which assesses and employs high-func-

tioning autistic adults and uses their special skills to provide services like software testing, data registration and logistics. Specialisterne receives legal help from Ashoka's partner in Denmark; Kromann Reumert and from many Ashoka staff and supporters around the world. Ashoka's ASN have been influential in his scaling efforts globally. Thorkil has received financial support from Ashoka.
